## TRANSFER GUIDELINES

Students not returning and/or transferring to another school should follow these guidelines:

1. Show a letter of acceptance from the transfer school or have the school fax (773-285-1633) or email letter of acceptance to [adjuran@cps.edu](mailto:adjuran@cps.edu)
2. LBPA cannot release students without confirmation of acceptance or parent/guardian signature.
3. According to State law, a student 18 years or older can withdraw themselves without parent consent.

## DRESS CODE

LBPA wants our students to have some freedom to be expressive in their dress, however, they must meet certain guidelines. Please read the list carefully to make sure your child is in compliance.

1. **No** clothing or apparel exhibiting or publishing any profane, obscene, or offensive materials;
2. **No** halters/tube/tank tops not covering midriffs; see-thru blouses/mini skirts without tights or shorts underneath
3. **No** revealing Bodysuits without a shirt or jacket covering to mid-thigh length;
4. Hoodies can be worn but **NO HOODS** to be worn in the building or in class
5. No fuzzy house slippers
6. No sagging pants; see-through leggings or inappropriately cut jeans
7. No outside coats are to worn in class unless authorized by administrators if building temperature permits.
8. **ABSOLUTELY NO** Bonnets; Du-rags; or Baseball caps!

**We also ask that parents use good judgment when volunteering and/or visiting and dress in a manner consistent with the student dress code.**
